

## **CV PROCESSING CONSENT**

In accordance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and Organic Law 3/2018, of 5 December, on the Protection of Personal Data and guarantee of digital rights (LOPDGDD), the personal data provided through your job application or resume via email [admin@whiteportcapital.com](mailto:admin@whiteportcapital.com) will be processed under the responsibility of WHITEPORT CAPITAL, S.L.U. Whiteport Capital will collaborate with third party service providers who may have access to your personal data and who will process said data in the name and on behalf of Whiteport Capital as a result of the recruitment process. Whiteport Capital undertakes to formalize with them the corresponding data processing contract, whereby it will impose on them, among others, the following obligations: to apply appropriate technical and organizational measures; to process the personal data for the agreed purposes and only according to Whiteport Capital's documented instructions; and to delete or return the data to Whiteport Capital once the purpose for which they were collected has been completed.

The personal data provided by you will be kept for a period of three years and would be subject to international transfers, to countries with a level of protection comparable to that of the European Union (European Commission adequacy decisions, standard contractual clauses and certification mechanisms).

Whiteport Capital guarantees the proper use of the information, and in particular, the full confidentiality of personal data contained in our files, as well as full compliance with the obligations regarding the protection of personal data.

You may exercise your rights of access, rectification, deletion, opposition, portability, limitation or opposition to the processing of your data, not to be subject to individualized decisions, as well as to withdraw your consent at any time, by mail to Velazquez 10, primera planta, 28001 Madrid or by e-mail to [admin@whiteportcapital.com](mailto:admin@whiteportcapital.com), with the reference "Data Protection", attaching a photocopy of your ID card or equivalent identification document.

Likewise, we inform you that in case you feel that your rights concerning the protection of your personal data have been violated, especially when you haven't obtained satisfaction in the exercise of your rights or when faced with actions that may be contrary to the law, you may file a complaint before the Spanish Data Protection Agency (the Control Authority in this matter), by writing to the same, C/ Jorge Juan, 6, 28001 - Madrid or through the web: <https://www.aepd.es>.

However, we recommend you contact Whiteport Capital beforehand, in order to solve the possible situation or conflict, if you consider it convenient.
